

APPLICATION PROCESS STEPS

- Create an online application on the [UIR CANDIDATURE](#) platform,
- Fill in the personal information,
- Select the master programs you wish to join (3 maximum);
- Download documents related to the application,
- Pay the application fees,
- Set for the admission tests,

APPLICATION FORM & DOCUMENTS

- Resume,
- Baccalaureate's transcripts,
- Baccalaureate's copy,
- Transcripts from S1 to S4;
- For bachelor's degree holders:
 - S5 and S6 transcripts
 - Copy of diploma or certificate of achievement.
- For students in 3rd year Bachelor's degree:
 - Before the academic results:
 - Enrollment Certificate for the current year,
 - After the academic results:
 - S5 and S6 transcripts
 - Copy of diploma or certificate of achievement.

ADMISSION STEPS

Master's programs are accessible through the below 3-step admission process:

1. Your Eligibility Assessment:

- Access to the RBS Master's programs is open to graduates of a bachelor's degree from an accredited school or a recognized equivalent diploma in the fields of economics and management.
- **NB:** access to the 2nd year of the Grande Ecole Program (PGE) only requires the validation of a Bac+3 level from an accredited school in the fields of economics and management and not a Bachelor's degree.
- Once the candidate is declared **ELIGIBLE**, he/she must pay the test fee (300 MAD) to move on to the next step.

2. Your Academic Record Assessment:

- Each file has a processing time depending on the number of files submitted and the time allocated for each file's assessment. For a quick processing, we advise you to submit your file as soon as possible.

- RBS will return your file to you to complete or correct it if there are any missing elements. The candidate has to resubmit it after correction.
- Once the record is processed and finalized, changes or modifications related to the chosen programs including their orders of preference is **NOT** possible (3 choices maximum).
- Once your application is validated, you must download the invitation to the admission tests via you're the applicant account.

3. The Admission Test Including written and oral tests.

- These tests not only test your aptitude for business management but also identifies your potential and your motivation for the targeted Master's program at Rabat Business School.
- Written Tests:
 - ✦ It is a multiple-choice question based test designed to assess candidates via 2 competencies:
 - ⑩ Verbal reasoning skills (1 hour),
 - ⑩ Logical reasoning skills (1 hour).
- Oral Test:
 - ✦ Individual admission interview
 - ⑩ During this interview, the jury systematically evaluates the candidate's main qualities (communication, openness and curiosity, leadership, motivation, values and integrity, entrepreneurial skills, organizational skills, creativity).
 - ⑩ It is conducted by a two-person jury typically including:
 - A professor from the school
 - A professional (often a graduate of the school)

ADMINISTRATIVE REGISTRATION

Admitted candidates will be asked to prepare an administrative file for their administrative registration (certified copies of diplomas obtained and/or certificates of achievement, transcripts, etc.). The complete list of documents will be sent to you after your admission.

International students:

International students will be required to provide the following documents at the time of their administrative registration:

- Certificate of authentication of the diploma, issued by the embassy in Morocco of the country concerned,
- Copy of the decree of equivalence of the diploma obtained with the Moroccan diploma.

In order to regularize their stay in Morocco, international students must also have the following documents before their arrival to Morocco:

- Criminal record issued by the competent authorities of the country of origin
- Birth certificate
- Certificate of good health issued by the attending physician.
